Which cars are not eligible for the EV incentive?

Premium cars, such as the Tesla Model S and BMW i8, are not eligible to the incentive because there is a cap of EUR60,000 (US\$67,800) for the purchase price. Only electric vehicles purchased after 18 May 2016 are eligible for the bonus and the owner must keep the new electric car at least nine months. The same rule applies for leasing.

What incentives are available for electric vehicles?

These incentives mainly take the form of purchase rebates, tax exemptions and tax credits, and additional perks that range from access to bus lanes to waivers on fees (charging, parking, tolls, etc.). The amount of the financial incentives may depend on vehicle battery size or all-electric range. Often hybrid electric vehicles are included.

Which countries offer tax incentives for electric vehicles?

Several regional government grant incentives for the purchase of alternative fuel vehicles including electric and hybrid vehicles. In Aragon, Asturias, Baleares, Madrid, Navarra, Valencia, Castilla-La Mancha, Murcia, Castilla y Leon electric vehicles are eligible to a EUR6,000 tax incentive and hybrids to EUR2,000.

How much will Nissan E-premium incentives fall each year?

Incentives will fall by EUR500 each year. In March 2016, Nissan Europe announced its support to the green car incentive and its commitment to double the government's E-premium incentive when buying a Nissan electric car, with a reduction of the purchase price of the same amount of the subsidy.
